

## TRICARE-AUTHORIZED RESIDENTIAL TREATMENT CENTERS

Following are the rate adjustments for those RTCs whose 1995 per diems were below the 30th percentile of all established fiscal year 1995 rates. The rates were adjusted by the lesser of the Consumer Price Index - Urban Wage Earners (CPI-U) for medical care for the annual reporting period of July 1, 1994, to July 1, 1995 (4.4 percent) or the amount that brought the rate up to the 30th percentile level (\$429). These rates are for payment of services provided on or after October 1, 1995.
